Chair welcomed everyone to the meeting. 2025 is election year and 7 councillors have been nominated and accepted for the upcoming term, leaving one vacant seat on the Parish Council. New Councillor details have been posted on the Community Website and Parish Noticeboard. Chair thanked the outgoing councillors Cllr. Griffin and Cllr. Crookes for their work during their time as Parish Councillors.

Unitary Council Elections take place on May 1st 2025.

Cllr. Clifton thanked participants in the litter pick for clearing rubbish on Crow Lane that has become an issue recently.

Action: Chair to amend letter which is given to businesses at Ollerton Business Park to include a reminder regarding littering along Crow Lane.

60/2025 Safety in the Parish

No new issues.

Pothole patching work is being carried out on Ollerton Lane.

061/2025 Highways and footpaths

a. St Michaels/Crow Lane 7.5 tonne weight restriction – on-going management, reporting, enforcement and further options.

Meeting with Chair, Councillors, PCC Jon Campion, Rod Lake from West Mercia Road Safety Team, Harry Guest from Shropshire Highways, Cllr. Gittins and residents took place on 20th February 2025.

PCC Jon Campion confirmed funding is available for "No Access to Ollerton Business Park" signage which Shropshire Highways would need to erect. 5 locations have been provided; Standford crossroads, Four Crosses crossroad, potentially outside the club, at the Village Green and entrance to St Michaels Way. Shropshire Council to approve locations and provide cost.

5 potential locations provided to Shropshire Council for installation of a VAS/SID. SC require evidence of speeding which will involve laying tapes across the road and there is a cost involved with this. Waiting for further communication from SC regarding costs.

No further update on the above, possibly due to SC being in a period of purdah prior to the elections on May 1st.

PC continue to send evidence of weight restriction breaches to DVSA and Operation Snap and continue to provide letters to Ollerton Business Park regarding the weight restriction at Crow Lane.

b. Eaton Road (village part) safety improvements. See above.

c. A41 working group - updates on new cross county group.

No further update from Cllr. Gittins. Chair has received feedback that one of the options being considered is average speed cameras are proposed on the section of the A41 from Tong to Tern Hill. Assessments and feasibility studies are ongoing.

d. Footpaths and public rights of way – to consider any queries which may impact on the parish. Footpath around the bus shelter is deteriorating. It is understood that one one quote has been obtained.

Action: Cllr. Hatfield and Cllr. Sale working to obtain quotes, 3 required if the work is more than £500.

No reported issues with public rights of way.

e. Streetlights - Lamp replacements. Dark skies initiative.

3 streetlamps obscured by vegetation on St Michaels Way. No action required on the concrete columns on St Michaels Way.

b. FTTP / Gigabit roll out in the Parish

Freedom Fibre have erected approximately 15 statutory notices to erect poles around the parish. Mostly on the highways but some outside properties.

Action (continued): Chair to contact Freedom Fibre to request those planned for outside properties to be relocated wherever possible.

Fairy Glen House has been placed on the Green. Stone painting event has been carried out. Co-ordinating with Church for the Easter Egg Hunt. Application has been submitted. Posters have arrived and will go up shortly.
