Chair welcomed everyone to the meeting. This will be Cllr. Gittins' last meeting with CEPC and Chair thanked him for his efforts on behalf of the PC during his time as Unitary Councillor for Shropshire.

Update from Best Kept Village sub-committee. Preparations for container planting has begun. Proposals for ground planting including a community vegetable patch on ground around bus stop presented. Application form is being worked on by Cllr. Barnes and Cllr. Griffin. Presentation from Combi Construction Ltd regarding planning application for land at Furbers, former salvage yard. Architectural drawings, site plan and floor plans presented followed by comments and questions from the floor.

043/2025 Highways and footpaths

a. St Michaels/Crow Lane 7.5 tonne weight restriction – on-going management, reporting, enforcement and further options.

Meeting with Chair, Councillors, PCC Jon Campion, Rod Lake from West Mercia Road Safety Team, Harry Guest from Shropshire Highways, Cllr. Gittins and residents took place on 20th February 2025.

PCC Jon Campion confirmed funding is available for "No Access to Ollerton Business Park" signage which Shropshire Highways would need to erect. 5 locations have been provided; Standford crossroads, Four Crosses crossroad, potentially outside the club, at the Village Green and entrance to St Michaels Way. Shropshire Council to approve locations and provide cost.

5 potential locations provided to Shropshire Council for installation of a VAS/SID. SC require evidence of speeding which will involve laying tapes across the road and there is a cost involved with this. Waiting for further communication from SC regarding costs.

PCC Campion confirmed that the Weight Restriction enforcement lies with the DVSA. Movements have reduced but size of vehicles has increased. No progress from Shropshire Highways relating to safety issues in the village, the recent fatality at the Four Crosses crossroads and the lack of progress on the A41 repairs.

Action: Chair to contact MP Mark Pritchard to escalate.

Following the recommendation from West Mercia Police to supply evidence of weight restriction breach to DVSA contact details for DVSA have been obtained.

Action: Evidence to be sent on behalf of the PC to DVSA and Operation SNAP. Resident Len Sambrook to assist in collating evidence.

Action: Chair to provide letter to Ollerton Park informing that details will be sent on a regular basis to DVSA.

Eaton Road (village part) safety improvements.

c. **A41 working group – updates on new cross county group.**No further update from Cllr. Gittins. Work is with T&W council.

d. Footpaths and public rights of way – to consider any queries which may impact on the parish. No issues. Currently all footpaths well lit. Footpath around the bus shelter is deteriorating. Action: Cllr. Hatfield and Cllr. Sale to obtain quotes, 3 if the work is in excess of £500 for repair.

No reported issues with public rights of way.

e. Streetlights - Lamp replacements. Dark skies initiative.

3 streetlamps obscured by vegetation on St Michaels Way. No action required, PC will consider condition of columns later in year.
